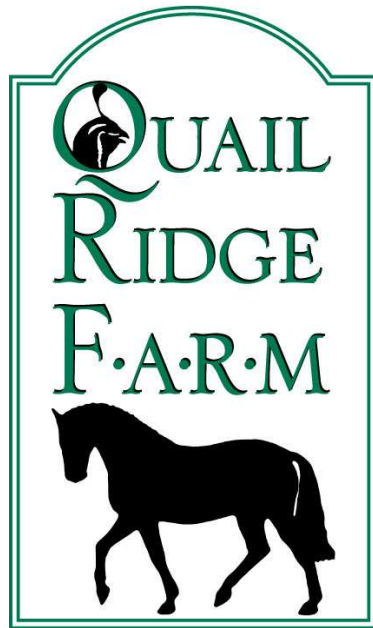

Show Information

Entries: Must be received by closing date. Entries received after closing date will be accepted upon space availability and assessed a \$10 late fee. Returned check fee \$20. Incomplete entries may be wait-listed if show is over-subscribed; otherwise entries are on a first-come first-served basis.

Refunds: Entries received and processed prior to closing date can be refunded less the \$10 office fee. After closing date, refunds can only be made for ride times that can be filled less the \$10 office fee.

Ride Times: Will be posted by 5:00 pm Thursday before the show at www.qridgefarm.com or sent to the e-mail address provided on the entry form. **It is the riders' responsibility to obtain ride times.**

Awards: Ribbons through fifth place; high point and reserve high point show awards; high point series award (awarded to highest average score among horses shown at all three shows). Classes may be cancelled, split or combined at management discretion.

Arenas: Warm-up arena 250'x150' with sand footing and dedicated lunging area; show arena standard size dressage court with sand footing; both arenas fully fenced.

Food: Snacks, beverages and real food available on grounds.

Attire: Casual attire accepted but must include paddock or tall boots and ASTM/SEI certified helmet.

Tack: All tack must conform to current USEF Rulebook.

Pets/Children: No dogs; children must be under adult control at all times.

Rules: All classes governed by the rules of the current USEF rulebook and will be conducted and judged in accordance therewith.

Video/Photos: We have arranged to have both a videographer and photographer on the grounds, please sign up upon arrival.

Directions: From Sacramento—Hwy 99 south to Dillard Road (4 miles south of Elk Grove) – or – From Stockton—Hwy 99 north to Dillard Road (5 miles north of Galt) – then – Dillard Road east 3½ miles to Walmort (3-way stop), Right onto Walmort 3½ miles to Reigl Road, turn left. Show facilities on right.

PLEASE NOTE: Trailer parking and warm-up arena are at *Blue Sky Farm* (10321 Reigl Road), Car parking and show arena are at *Quail Ridge Farm* (10333 Reigl Road).

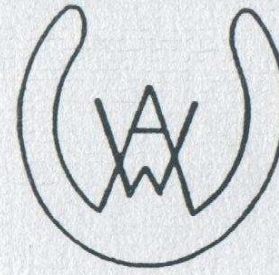
